Warranty:

This warranty is valid only in accordance with the conditions set forth below:

1. If within one year from date of purchase your networked mobile device, Phone, GPS, wireless computing device, Bluetooth® Device or any other commercially available networked radio transceiver device is properly inserted, and kept in a properly closed and undamaged Dead Zone Bag™ it will not be able to transmit or receive a radio signal until you open the bag. If said device is capable of transmitting or receiving radio frequencies at distances greater than 10 feet on the frequencies and bands listed below without the undamaged bag being opened: we will refund your full purchase price for any standard size (non-custom) Dead Zone Bag™

800 MHz - 950 MHz and 1900 MHz used for cellular phones 1200 MHz - 1500 MHz (1.7 GHz - 2.1 GHz) used in GPS Satellite Navigation (SATNAV) 1500 MHz - 2100 MHz (1.7 GHz - 2.1 GHz) wireless internet including 3G and 4G 2000 MHz - 5800 MHz (2 GHz - 5.8 GHz) band used for Bluetooth® and 802.11 WLAN Devices (WiFi)

- 2. Wrinkles and other superficial cosmetic blemishes which do not affect the radio-physical properties of the bag, and normal wear and tear are not covered by this warranty. This warranty applies to consumer use only, and is void when the product is used in a commercial or institutional setting.
- 3. The warranty extends only to the original consumer purchaser and is not transferable. In addition, proof of purchase must be demonstrated. This warranty is void if the product has been subject to accident, misuse, abuse, improper maintenance or repair, or unauthorized modification.
